**Lakeway, TX – SAS OPPOSES COOK COUNTY ORDINANCES**

The Cook County (Illinois) Board is considering two new ordinances that will have adverse effects on honest gun-owners in the region. One will overrule home-rule municipalities, and eliminate most gun shops and gun shows.

The other will expand the Chicago gun ban to all of Cook County. In addition to added restrictions on both handguns and long guns, it includes a registration scheme for the limited guns that would be allowed in the county. Furthermore, the County Board President, the Board, and the Sheriff would have the power to determine which additional firearms might be determined "unregisterable".

SAS understands that well-intentioned people are searching for solutions to the horrendous violence that is occurring, especially in our cities. However, taking guns from the honest citizen does nothing to limit crime. In fact, it enhances the opportunities for the predators to act without fear of opposition. Disarming the public increases the number of potential victims.

Violence and crime are serious complex problems. Making a scapegoat of an inanimate tool will do nothing to solve them.
